## **Making a Complaint**

You can complete this form if you wish to make a formal complaint about a Landlord where you believe they may have breached certain areas of rental law and want the RTB to investigate.

The RTB will also write to the Landlord to advise them that an investigation has commenced. Please note: Where you make a formal complaint the Landlord will also receive a copy of this complaint form.

### What the RTB can Investigate

All complaint forms submitted to the RTB will be acknowledged and reviewed.

The RTB can investigate complaints about Landlords of Private Residential Tenancies and Approved Housing Bodies who may have breached certain aspects of rental law.

- Breaches of the Law:
  - Failure to comply with the RPZ requirements including setting the rent above 4% in an RPZ and seeking to inappropriately rely on the exemptions to the RPZ contained in the Act;
  - Failure to register the tenancy and/or notify the RTB where the amount of rent changes during the year;
  - Knowingly providing false or misleading information on a Notice of Termination. Including; Failing to offer a tenant their tenancy back where it has been terminated for certain specific grounds which are no longer relevant e.g. property not sold, or family member no longer in occupation, where the tenant has fulfilled their obligation in providing contact details to the Landlord, should the property become available for re-let.
  - The complaint relates to improper conduct as defined in the law, is made in good faith, is not frivolous or vexations or without substance or foundation.

The RTB will write to you if your complaint will be investigated by the RTB and explain the next steps in the process.
